NOTICE OF PUBLIC MEETING

To be held by the Toronto and East York Community Council (Under the Planning Act)

Request to Amend the Zoning By-law Application 21 156568 STE 11 OZ

Location of Application: 502 and 508-510 Spadina Avenue

Applicant: Design Plan Services

Date: May 26, 2022

Time: 10:00 a.m., or as soon as possible thereafter

Place: Council Chamber, Toronto City Hall and by Video Conference

PROPOSAL

The application to amend the Zoning By-law proposes to redevelop and expand the existing Scott Mission buildings on-site with a 9-storey affordable residential building with a total gross floor area of 11,635 square metres and a density of 5.65 times the area of the lot. The overall proposed height is 30 metres (36.5 metres inclusive of the rooftop mechanical equipment). A total of 109 affordable units are proposed with a unit mix comprised of 99 bachelor units, 5 one-bedroom units and 5 two-bedroom units. Floors 1-4 and the 2 underground levels of the building would include non-residential uses, such as food and clothing banks, a kitchen and a cafeteria, supporting the affordable residential units.

A total of 151 bicycle parking spaces would be provided within the underground levels and on the ground floor. A total of 5 vehicular parking spaces and one Type G loading space would be provided on the surface level at the southwest corner of the lot. Vehicular access, including loading, would be provided off Spadina Avenue.



Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable



grounds to do so. You may submit comments to the City Clerk, attention: Ellen Devlin, Administrator, Toronto and East York Community Council, at the address, fax number or e-mail set out in this notice.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
