Pay-and-Display Parking - Glen Morris Street, Washington Avenue, Dalton Road, Eastern Avenue and Hiawatha Road (Delegated)

SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval for the installation of on-street paid parking on a number of local streets in Wards 11, 13 and 14. Transportation Services and the Toronto Parking Authority (TPA) staff have identified new pay-and-display parking spaces in these wards that will support the local community and area businesses by encouraging a regular turnover in the on-street parking supply. The proposed parking changes will replace the existing unpaid 1-hour parking that is currently in effect. The proposed changes will not impact the flow of traffic and will encourage parking turnover.

While this report seeks Community Council approval for the installation in various Wards, this is an ongoing initiative, and Transportation Services and TPA staff will continue to review and report on potential new on-street paid parking opportunities throughout the City of Toronto.

A companion report, titled "Pay-and-Display - Various (Non-Delegated)" outlines the required non-delegated parking amendments for locations with Toronto Transit Commission (TTC) service.

RECOMMENDATIONS

The Director, Traffic Management, Transportation Services recommends that:

1. Toronto and East York Community Council authorize the amendments to parking regulations required to establish new on-street paid parking locations, as set out in

Attachments 2 and 3, to the report dated June 13, 2022 from the Director, Traffic Management, Transportation Services.

FINANCIAL IMPACT

All cost associated with the necessary signage changes are included within the Transportation Services 2022 Operating Budget.

All costs associated with the installation of parking machines will be assumed by the Toronto Parking Authority. These recommendations, if fully implemented, are projected to generate an increase in annual gross revenue of up to \$190,000 from the on-street paid parking program.

DECISION HISTORY

This report addresses a new initiative.

COMMENTS

Transportation Services and TPA staff have reviewed the parking regulations at the following locations within the identified Wards. Transportation Services is recommending converting the following locations from 1 hour parking to paid-parking:

Ward 11

- Glen Morris Street, south side, between Spadina Avenue and Huron Street 15 spaces
- Washington Avenue, north side, between Spadina Avenue and Huron Street 15 spaces
- Dalton Road, east side, between Bloor Street West and a point 15 metres north 2 spaces

Ward 13

- Eastern Avenue, north side, between Sackville Street to Trinity Street 4 spaces
- Eastern Avenue, south side, between Cherry Street and a point 30.5 metres east of Trinity Street 20 spaces

Ward 14

 Hiawatha Road, east side, between Gerrard Street and a point 16 metres north - 3 spaces

On-street parking spaces are typically the most convenient in serving areas of high demand, including local business areas. The on-street parking supply is meant to serve a short-stay need (considered less than three hours), which is reinforced by parking rates that encourage a turnover in the on-street parking supply so that it is available to as many users as possible.

There are no changes proposed to the existing peak period stopping and parking prohibitions. The proposed changes will not impact the flow of traffic and will encourage parking turnover. The proposed amendments will result in approximately 60 new onstreet paid parking spaces.

The Councillors for all Wards effected have been consulted about the recommendations contained in this staff report.


