PROPOSAL

This application to amend the Zoning By-law proposes to permit a 15 storey mixed-use building with retirement residential uses including 137 independent, assisted living and memory care units and rooms and 7,561 square metres of non-residential floor area at 462 Wellington Street West. There is a heritage building on the site that is proposed to be conserved and used for office and retail purposes. The below grade garage is proposed to extend to the property adjacent to the north at 489-539 King Street West to provide for shared access between properties and parking for the new development at 462 Wellington Street West.
