## Comments for distribution to the Chair and Members of the Toronto and East York Community Council

RE: TE 34.188 Agenda item Speed Limit Reduction - Broadview Avenue

Dear Chair and Members of the Toronto and East York Community Council,

I am writing on behalf of the Helliwell Place Residents' Association (Helliwell RA). We represent about 1,500 residents. Our association area extends along Broadview Avenue from Pretoria Avenue to Mortimer Avenue, with a pocket on Nealon Avenue. We remain an active voice on planning and other relevant issues of benefit to our community, including those in keeping with Toronto Council's Vision Zero Road Safety Plan.

We support Councillor Fletcher's recommendations that:

- 1. Toronto and East York Community Council reduce the speed limit along the following roadway from 50km/h to 40km/h:
- a. Broadview Avenue between Danforth Avenue and O'Connor Drive
- Toronto and East York Community Council direct the General Manager, Transportation Services to, to install relevant speed limit signage along the roadway outlined in recommendation 1 above.

Typically (by daily observation outside of rush hour) too many drivers go well past the 50 KPH speed limit, especially on the straightaway stretch between Pottery Road/Mortimer and Pretoria. A speed reduction as per Councillor Fletcher's recommendations would make our community safer and be in keeping with Toronto Council's Vision Zero Road Safety Plan. Additionally such a speed limit, would put the speed of this stretch of Broadview Avenue in line with other similar local arterial roadways.
