\$1,921,898 including HST and all applicable charges
\$1,730,729 net of HST recoveries

Contract is expected to start on date of award and end on December 31, 2023.

FINANCIAL IMPACT

The total contract award identified in this report is \$1,921,898 including all applicable taxes and charges. The cost to the City is \$1,730,729 net of HST recoveries.

The engineering estimate for this project is \$1,389,577 net of all taxes and charges.

Funding is available in the 2023 Approved Operating Budget for Transportation Services. Additional funding details follow in Table 1.
