Contract is expected to start on June 26, 2023 and end on December 31, 2023.

FINANCIAL IMPACT

The total contract award identified in this report is \$2,293,985 including all applicable taxes and charges. The cost to the City is \$2,065,804 net of HST recoveries.

The engineering estimate for this project is \$1,783,168 net of all taxes and charges.

Funding is included in the 2023 Capital Budget for Transportation Services.
