Contract is expected to start on date of award and end on December 31, 2025.

FINANCIAL IMPACT

The total contract award identified in this report is \$10,525,402 net of all applicable taxes and charges, \$11,893,704 including all applicable taxes and charges. The cost to the City is \$10,710,649 net of HST recoveries.

The engineering estimate for this project is \$8,914,781.76 net of all applicable taxes and charges.

Funding is included in the 2023 Approved Capital Budget and the 2024-2032 Approved Capital Plan for Toronto Water. Funding details are summarized in Table 1 as follows.
