### 2023 OPERATING BUDGET BRIEFING NOTE Comparison of Social and Community Investments: 2014 vs. 2023 Budgets

#### Issue/Background:

- On January 13<sup>th</sup>, the Budget Committee requested the Chief Financial Officer and Treasurer provide a briefing note on police spending compared to social and community investments, by setting out the net operating budget increase (in dollars and as a percentage increase), for the year 2014 compared to now, for the following.
  - 1. Police Service budget;
  - 2. All housing operating budget spending;
  - 3. City subsidy to the TTC (with and without COVID-19 costs); and
  - 4. Social Development, Finance and Administration budget
- This briefing note provides a comparison of the relevant 2014 and 2023 budget information.

#### **Key Points:**

- As compared to 2014, the City has significantly increased its direct investments in all the social and community investment areas included in this briefing note.
  - This briefing note focuses on the City's increased net investments which represent the added investments directly supported by the City's property tax base.
- In summary, the following increases in net operating investments are made in the 2023 Operating Budget as compared to the City's 2014 Budget:
  - Toronto Police Service: \$209 million (22%)
  - Additional social and community investments: \$801.1 million (94%) comprising of:
    - Housing-Related Services Budgets: \$340 million (123%)
    - Base Operating Subsidy to the Toronto Transit Commission: \$412 million (75%)
    - Social Development & Housing Administration: \$49 million (164%)

• As detailed in the figures above, the Net Operating Budget for Toronto Police Service has increased proportionately less and at a reduced rate than other investments referenced.

#### 1. Toronto Police Services Budget, 2014 vs. 2023

- The 2014 Net Operating Budget for the Toronto Police Service was \$957.7 million.
- The 2023 Net Operating Budget for the Toronto Police Service is \$1.167 billion, an increase of \$208.8 million or 22% over the 2014 Operating Budget.

#### 2. Housing-Related Operating Budgets, 2014 vs. 2023

- The City of Toronto's housing-related services are primarily provided by the:
  - Housing Secretariat;
  - Shelter Support and Housing Administration (SSHA); and
  - Toronto Community Housing Corporation (TCHC) and the newly created Toronto Seniors Housing Corporation (TSHC).
    - TCHC and TSHC are City corporations that are managed through a separate Board of Directors. Each year they receive subsidy payments from the City of Toronto.
- The 2014 Net Operating Budget for housing-related services was \$275.7 million including:
  - \$1.2 million for the Housing Secretariat;
  - \$23.4 million for SSHA; and
  - \$251.1 million provided in City funding as a subsidy to TCHC.
- The 2023 Net Operating Budget for housing-related services is \$615.8 million, excluding COVID-19 financial impacts, including:
  - \$146.3 million for the Housing Secretariat;
  - \$173.7 million for SSHA; and
  - \$295.8 million in subsidies for TCHC and TSHC.

• Overall, this reflects an increase of \$340.1 million in net investments over 2014, or the equivalent to a 123% increase.

\*The 2014 values for SSHA and TCHC combined (\$274.5 million) reflect the total City funding dedicated to these services including property tax funding (\$198 million) and other City sources such as reserve draws, and is displayed to show the full TCHC subsidy provided.

#### 3. City Subsidies to the Toronto Transit Commission, 2014 vs. 2023

- City subsidies to the TTC have increased from \$546.9 million in 2014 to \$958.7 million in 2023, when excluding COVID-19 funding, representing an increase of \$411.8 million or 75%.
- When including COVID-19 impacts of \$366.4 million in 2023, the City's subsidy to the TTC has increased by \$778.2 million, or 142%, resulting in a total 2023 operating subsidy of \$1.325 billion.

## 4. Social Development, Finance and Administration (SDFA) Net Operating Budget, 2014 vs. 2023

• The 2014 Net Operating Budget for SDFA was \$30.0 million. The 2023 Net Operating Budget for SDFA is \$79.2 million net, representing a total increase of \$49.2 million or 164%.
