Designation of the King-Spadina Heritage Conservation District under Part V of the Ontario Heritage Act - OLT Hearing - Supplementary Report

REASON FOR CONFIDENTIAL INFORMATION

This report contains advice or communications that are subject to solicitor-client privilege. This report contains information regarding potential litigation.

SUMMARY

City Council designated the King-Spadina Heritage Conservation District and adopted the King-Spadina Heritage Conservation District Plan (the "King-Spadina HCD") under Part V of the *Ontario Heritage Act* at its meeting of October 2, 2017. The King-Spadina HCD was subsequently appealed to the Ontario Land Tribunal (the "OLT").

The OLT has scheduled a 25 day hearing on the merits of the King-Spadina HCD commencing on January 15, 2024. The City Solicitor requires further direction on the matter.

As permitted by the Tribunal's modified procedural order, on October 13, 2023, the remaining appellants to the King-Spadina HCD filed proposed modifications to the HCD Plan. The City Solicitor has reviewed the proposed modifications with City staff and has determined that further direction from Council is required on this litigation matter.

RECOMMENDATIONS

The City Solicitor recommends that:

1. City Council adopt the recommendations contained in the Confidential Attachment 1 to this Supplementary Report from the City Solicitor.

2. City Council authorize the public release of the confidential instructions to staff contained in Confidential Attachment 1, Confidential Appendix "A", and Confidential Appendix "B" to this Supplementary Report from the City Solicitor, if adopted by City Council, at the discretion of the City Solicitor.

3. City Council direct that all other information contained in Confidential Attachment 1 to this Supplementary Report from the City Solicitor is to remain confidential at the discretion of the City Solicitor, as it contains advice and information, which is subject to solicitor-client privilege.

FINANCIAL IMPACT

There is no financial impact arising from the adoption of the Confidential Recommendations beyond what has already been approved in the current year's budget.
