

Changes to Business Improvement Area Boards of Management

SUMMARY

The purpose of this report is to make changes to The Eglinton Way and Uptown Yonge Business Improvement Area (BIA) Boards of Management, in accordance with the requirements of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas. The Eglinton Way and Uptown Yonge BIAs fall within two Community Council boundaries.

RECOMMENDATIONS

COMMENTS

From time to time, it is necessary to remove BIA Board of Management directors who are no longer able to serve, and add new directors to fill vacant positions, as set out in Chapter 19 of the Toronto Municipal Code. Council members are appointed by right-of-office to the boards of BIAs in their wards.

The Eglinton Way

The removal of one (1) director from The Eglinton Way BIA Board of Management who has resigned will increase the number of vacancies on the board from one (1) to two (2). Quorum will be reduced to five (5).

Uptown Yonge

The appointment of one (1) director to the Uptown Yonge BIA Board of Management will decrease the number of vacancies on the board from nine (9) to eight (8). Quorum will increase from three (3) to four (4).
