Keele & Eglinton Residents (K.E. Residents) is dedicated to fostering equitable and inclusive spaces for children, youth, and community members within the Eglinton West - Little Jamaica community. Through active community engagement, K.E. Residents hosts and supports various projects and events aimed at strengthening neighbourhoods and fostering community connections. In line with our commitment to community leadership, K.E. Residents prioritizes Black-led and Afro-Caribbean leadership, recognizing the importance of empowering these voices.

We are writing in support of the City Council adopting the Toronto Action Plan to Confront Anti-Black Racism – Year Four Update. The Plan works to address the ongoing impacts of anti-Black racism on the lives of Black Torontonians.
