

**City of Toronto Act, 2006 Public Notice
Updates Chapter 441, Fees and Charges**

Toronto City Council will be considering recommendations to adopt amendments to City of Toronto Municipal Code Chapter 441, Fees and Charges.

It is proposed that the amendments be adopted at the City Council meeting to be held on July 19-21, 2023, or at a subsequent meeting. If adopted by City Council, the amendments to City of Toronto Municipal Code Chapter 441, Fees and Charges will:

1. Authorize vendor fees detailed in Appendix E and consistent with the 2023 Budget to be added to the current police reference checks and other police documents fees charged to the public by Toronto Police Service and amend City of Toronto Municipal Code Chapter 441, Fees and Charges to reflect these new fees.
