

City of Toronto Act, 2006
Updates to Chapter 441, Fees and Charges

Toronto City Council may be considering recommendations to adopt amendments to City of Toronto Municipal Code Chapter 441, Fees and Charges.

It is proposed that the amendments be adopted at the City Council meeting to be held on September 6, 2023, or at a subsequent meeting.

While no specific amendments are included in the report titled “Updated Long-Term Financial Plan”, the Executive Committee or Toronto City Council may amend Toronto Municipal Code Chapter 441, Fees and Charges to change existing user fees and charges or add new user fees and charges not contemplated in the report.
