ATTACHMENT 2 - LIST OF CITY-OWNED 'HOUSING READY' SITES

The tables below show City-owned sites (defined as lands owned by the City of Toronto and its Agencies and Corporations) that are currently within the City of Toronto, Build Toronto and Toronto Community Housing Corporation's portfolios.

There are a **total of 52 sites**, **which are estimated to deliver between 16,000 and 17,000 rent-controlled homes** (including RGI, affordable rental and market rental homes) that are considered 'housing ready' and further classified as either:

- 1) **High Priority Sites** (targeted construction start within 12 months) defined as projects which are or may be ready to proceed to construction in the near term.
- 2) Rezoned Sites (12 to 36 months to construction) defined as sites with projects where Council has already approved the rezoning but are still required to go through final stages of detailed design and/or Site Plan Approvals before being construction ready. These sites can be accelerated towards construction with through expedited City reviews and approvals, as well as funding and financing from the federal and provincial governments.
- 3) Sites with Initial Approvals (24 to 36 months to construction) defined as sites which have already been designated for housing and have received some form of City approval (e.g., initial Council direction, Initial Development Plan (IDP) approval, or approval for Open Door incentives), but are not yet rezoned. Delivery of these sites can accelerate through expedited City reviews and approvals, as well as funding and financing from the federal and provincial governments.

Note, once construction has begun, occupancy timeframes range from 12 to 18 months for low-rise buildings, 18-24 months for midrise, and 24-36 months for tall buildings.
