# Authority to Enter into License Agreement with Toronto Cultural Advisory Corporation to Operate the Arts in the Parks Program

#### **SUMMARY**

Parks, Forestry and Recreation has been collaborating with the Toronto Cultural Advisory Corporation operating as the Toronto Arts Council (TAC) to deliver the Arts in the Parks program since the summer of 2016. The program has been renewed on an annual basis since then. The program has provided accessible opportunities for artists and free access to view installations and participate in programming to residents and visitors.

This report seeks authority to enter into a renewed five-year agreement, in order to formalize the licence agreement with TAC and grant licensee authority to continue operating the Arts in the Parks program for a term of five years across 26 select City park locations and one property managed by Toronto Regional Conservation Authority.

#### **RECOMMENDATIONS**

The Acting General Manager of Parks, Forestry and Recreation recommends that:

1. City Council authorize the Acting General Manager, Parks, Forestry and Recreation to enter into a nominal license agreement with Toronto Cultural Advisory Corporation operating as the Toronto Arts Council for the use of parks by various artists to be selected by Toronto Arts Council for the "Arts in the Parks" program for a term of five years, renewable for an additional five-year term at the sole discretion of the Acting General Manager, Parks, Forestry and Recreation, on terms and conditions satisfactory to the Acting General Manager, Parks, Forestry and Recreation and in a form satisfactory to the City Solicitor.

#### FINANCIAL IMPACT

Consistent with previous terms and conditions, Toronto Arts Council (TAC) will pay the City nominal licence fees for the use of City parks to run the Arts in the Parks program. Staffing resources and expenditures associated with the set up and dismantling of the exhibits will be charged on a full cost recovery basis to individual artists and will be recovered by TAC. There are no foregone revenues because there is no charge for the Council-approved "Arts in Parks" permit category. No additional funding associated with this initiative in current and future years is required.

The Interim Chief Financial Officer and Treasurer has reviewed this report and agrees with the financial implications as identified in the Financial Impact section.

#### **DECISION HISTORY**

At its meeting on March 31, 2016, City Council authorized Parks, Forestry and Recreation to enter into a license agreement with Toronto Cultural Advisory Corporation operating as the Toronto Arts Council.

At its meeting on November 3, 2015 City Council approved the introduction of an "Arts in Parks" permit category and authorized Parks, Forestry and Recreation to enter into a license agreement with the Toronto Arts Council (TAC) to pilot the Arts in the Parks pilot program and provide grants to artists for various multimedia activations in approximately 22 parks in 22 wards.

#### **COMMENTS**

The Arts in the Parks program brings art to select parks in neighborhoods across Toronto. Events are free to residents and visitors, increase public use of parks and the vibrancy of communities in underserved neighbourhoods and create opportunities for residents and visitors to experience art and support artists.

The Toronto Cultural Advisory Corporation operating as the Toronto Arts Council (TAC) accepts applications from local artists annually which are evaluated by a panel that includes Parks, Forestry and Recreation (PFR) staff. TAC will ensure that artists' installations meet City conditions to receive the "Arts in Parks" permit category, approved by Council in 2015 to support Toronto's local arts and cultural landscape.

Event proposals are reviewed and where events include one or more of the criteria that would classify them as a Not-for-Profit or a Commercial Special Event, permits are required to be obtained by the artists or groups at the current, Council-approved rates. This can include sale or service of food or alcohol, installation of large tents, or stages, entrance fees, etc.

Successful artists and groups receive grants to undertake approved art programs by TAC and the City issues permits at no-cost. Artists and groups are responsible for all costs associated with their events and animations and any associated staffing costs incurred by the City for parks maintenance are appropriately charged back to TAC, and TAC recovers those costs from artists or arts groups.

Approved art programming can vary from a one-day event to a longer term activation, and is free and open to residents and visitors. Fixed artworks including all exhibits and murals are not to be permanently left in any park without prior approval.

Since Arts in the Parks was introduced in 2016, 204 events have been hosted in City parks, an average of 26 events per season from 2016-2023. The program has been well received by the general public and Toronto's arts community.

In consultation with TAC, PFR staff will identify suitable parks for existing and future artists' proposals to initiate Arts in the Parks programming. TAC will activate 26 select City park locations, as outlined in Attachment 1, that PFR will incorporate into a license agreement, at a nominal licence fee consistent with previous terms and conditions for the Arts in the Parks program.
