Notice was given and a Public Hearing was held on Thursday, May 4, 2023, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

73 Brooklawn Avenue (Municipal Address to be Determined) - Lot 2. To permit the construction of a new 2-storey detached dwelling. The existing residential dwelling will be demolished. Refer to Consent Application B0050/20SC and Minor Variance Applications A0315/20SC, A0317/20SC and A0318/20SC.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. [10.20.40.10.(2) Maximum Height of Specified Pairs of Main Walls]

The permitted maximum height of all side exterior main walls facing a side lot line is 7.0 metres.

The proposed height of the North side exterior main walls is 8.49 metres for 11.5% of the width of the wall, with the remainder at 7.71 metres.

The proposed height of the South side exterior main walls is 8.49 metres for 10.4% of the width of the wall, with the remainder at 7.71 metres.

2. [900.3.10(197/1462) - Exceptions for RD Zone]

The permitted maximum floor space index is 0.6 times the area of the lot or a maximum of 204 m², whichever is the lesser.

The proposed floor space index is 0.625 times the area of the lot and 255.09 m².

3. [10.20.30.20.(1) Minimum Lot Frontage]

The required minimum lot frontage is 10.5 metres. The proposed lot frontage is 10.06 metres.
