PROPOSAL

The application proposes to demolish the existing buildings at 2-12 Oakburn Crescent, which currently contains 66 rental dwelling units in connection with an Official Plan and Zoning By-law Amendment application (21 185510 NNY 18 OZ) to redevelop 2-12 Oakburn Crescent with a new residential building. Tenant relocation and assistance will be provided to mitigate hardship for impacted eligible tenants.

A Rental Housing Demolition and Conversion application (23 124230 NNY 18 RH) under Section 111 of the *City of Toronto Act*, 2006 (Chapter 667 of the Municipal Code) has been submitted to permit the demolition. Under the *City of Toronto Act*, 2006, the demolition of a rental property with six or more dwelling units is prohibited without obtaining a permit from the City. Decisions by City Council on the rental housing demolition application are not subject to appeal to the Ontario Land Tribunal (OLT).
