## City of Toronto - Toronto Parking Authority Relationship Framework - Update

### SUMMARY

The purpose of this report is to provide an update to the Toronto Parking Authority (TPA) Board of Directors about the City-TPA Relationship Framework, which was adopted by City Council, with amendments, at its meeting of March 29, 30 and 31, 2023.

Amendments to the Relationship Framework include a recognition that TPA will support the City's Housing Action Plan and assist the City to reach net-zero climate pollution by 2040, in a manner consistent with TransformTO. These changes, as well as other minor changes made to reflect input from City Divisions and Agencies are summarized in Table 1 and included in an edited version of the document appended to this report (refer to Attachment 1).

In addition to amendments to the Relationship Framework, City Council also requested that the President, TPA report on the feasibility of providing parking discounts to veterans at the April 21, 2023 meeting of the Board. Although there is insufficient time to adequately address this request at the April 21, 2023 meeting, TPA will bring forward a response to address this request at the Board of Director's next meeting of May 25, 2023.

#### RECOMMENDATIONS

The President, Toronto Parking Authority recommends that:

1. The Board of Directors of the Toronto Parking Authority, receive this report for information.

## FINANCIAL IMPACT

There are no financial implications from the adoption of the recommendations in this report.

#### **DECISION HISTORY**

At its meeting of March 21, 2023, Executive Committee recommended that City Council adopt the Relationship Framework of the City with the Toronto Parking Authority as set out in Attachment 1 to the report (March 7, 2023) from the City Manager, as amended by Recommendation 2 below.

2. City Council amend Section 2.2, City Strategic Objectives in Providing the Services, in Attachment 1 to the report (March 7, 2023) from the City Manager by adding the following new Part 9:

9. Supporting the City's Housing Action Plan objectives by:

a. working in consultation with the Executive Director, Housing Secretariat and the Chief Executive Officer, CreateTO to identify underutilized parking facilities and parking facilities within Protected Major Transit Station Areas for the purpose of redevelopment; and

b. supporting plans for redevelopment of parking facilities that prioritize the provision of new affordable housing.

3. City Council authorize the City Manager, in consultation with the City Solicitor, to make technical changes to the Relationship Framework and any other changes as may be required to give effect to City Council's decisions

City Council subsequently adopted Item EX3.4 at its meeting of March 29, 30 and 31, 2023 with the following amendments:

1. City Council amend the City of Toronto Relationship Framework for the Toronto Parking Authority in Attachment 1 to the report (March 7, 2023) from the City Manager to add a new section 4.3:

"4.3. The Toronto Parking Authority shall, in delivering this mandate, do everything practicable to assist the City to reach net-zero climate pollution by 2040, in a manner consistent with TransformTO."

2. City Council request the Board of Directors of Toronto Parking Authority to report on the feasibility of providing parking discounts to veterans at their April 21, 2023 meeting.

At its meeting on May 27, 2022, the Board of Directors of the Toronto Parking Authority considered the City Manager's report with the draft Relationship Framework provided for information and feedback and received it without suggested amendments.

### COMMENTS

The Relationship Framework is City Council's governing instrument used for setting out the specific mandate, delegations of authority, legislative framework, policy directions and accountability for City Boards, and their relationship to the City of Toronto. The City Manager's Office has worked with TPA to develop a City-TPA Relationship Framework, which will promote an effective and collaborative relationship between the City and TPA, while providing clarity about TPA's mandate, City Council's delegations of authority, the responsibilities and obligations of TPA including key operating principles, reporting requirements, and expectations around governance, transparency and accountability.

Following TPA Board of Director's review of the draft Relationship Framework at the May 27, 2022 Board meeting, several amendments have been incorporated into the City-TPA Relationship Framework that was presented to City Council. In its adoption of EX3.4, City Council also included additional amendments. All of these amendments are summarized in Table 1 and included in an edited version of the Relationship Framework appended to this report (refer to Attachment 1).

The amendments identified in Table 1 omit stylistic and formatting changes. All changes will be incorporated by the City Solicitor into the final version of the City-TPA Relationship Framework.

As TPA continues its business transformation, it is expected that both the Relationship Framework and City Council's delegated authorities will require further updates/amendments to include a more fulsome clarification of TPA's mandate and the adjustments to TPA's delegation of authorities that will be needed to provide TPA with the operational flexibility to deliver its expanded scope around electric vehicle charging infrastructure and emerging role as a mobility services provider.
