These funds will be utilized through the annual budget process, with the goal of generating 11,780 net new permitted residential homes over the upcoming three-year period (2023-2026).</p>		<p>This motion seeks City Council's approval of the recommendations for the City to receive approximately \$471 million in anticipated funding over four equal annual installments, beginning in the fourth quarter of 2023. This funding is critical to supporting Toronto and Canada's shared housing objectives, including advancing delivery of the City's Housing Action Plan, HousingTO Plan and the federal National Housing Strategy targets. Specifically, Housing Accelerator Fund investments will provide Toronto with a predictable funding stream over the next three years, which is pivotal to unlocking projects and accelerating the delivery of new homes, particularly purpose-built affordable rental homes near transit.</p>
