## PROPOSAL

The application seeks amendments to the City of Toronto Zoning By-law 569-2013 to permit development on the southeast corner of the subject lands for a six-storey self-storage facility. The proposed development will have a gross floor area of 17,369 square metres. 16 parking spaces are proposed of which five spaces will be located interior to the building while the remaining 11 will be located at the west side of the proposed building. The main vehicular access for the proposed development will be accessed through a shared access with the existing Home Depot off Eglinton Avenue East and Landmark Boulevard. The existing Home Depot Store would remain on site.


