#### Greetings!!

I trust this message finds you well. My name is Vipul Keniya, a member of the Board of Directors at 10 Stonehill Court, and I am writing on behalf of the 154 residents within our community. We are expressing collective concerns regarding the proposed amendment to the zoning by-law application #21 204794 ESC 22 OZ for the construction of a residential building at 20 Stonehill Court.

We wish to convey our deep apprehensions concerning the outlined construction project, which intends to develop 29 high-rise buildings on the south side and 11 mid-rise buildings on the north side of 20 Stonehill Court. While recognizing the necessity of urban development for societal progress, it is imperative to emphasize the need for a comprehensive understanding of the project's impact on our community members, especially our senior citizens, children, and residents at large. Additionally, we seek acknowledgment of the considerable risks posed to our green spaces, parking facilities, historic buildings, water bodies, and, notably, the privacy of our residents.

#### **Adverse Impact on Privacy:**

- The construction project will dramatically alter the landscape of our community, affecting the privacy of residents living in nearby homes. Higher buildings can lead to overlooking issues, invading the personal space and privacy of individuals and families. Preserving the privacy of our residents is paramount to maintaining the harmony and security of our community.
- The disturbance caused by the construction activities poses a significant threat to the privacy of our senior citizens. Their homes, once havens of peace, could become exposed to the prying eyes of construction workers and passersby, causing distress and discomfort.
- Similarly, children need a secure environment to grow and develop, which is jeopardized when their privacy, play area and safety is compromised due to construction-related activities.

#### Adverse health Impact on Senior Citizens and Children:

- The noise, air pollution, and vibrations from construction activities adversely affect the health of our senior citizens. Prolonged exposure can worsen respiratory conditions, leading to a decline in their overall well-being. For our children, such disruptions hamper their ability to concentrate, impacting their education and mental health.
- Senior citizens often have established routines that contribute to their overall well-being. Construction activities, with their associated noise, vibration, and changes in the environment, can disrupt these routines. Such disruptions may lead to stress, anxiety, and a decline in mental and emotional well-being for seniors. Similarly, children, who

thrive on stability and routine, may experience heightened stress levels and emotional challenges due to the upheaval caused by construction projects.

• Both senior citizens and children benefit from access to outdoor spaces for physical activity and recreation. Construction projects may limit or entirely restrict access to parks, playgrounds, and other outdoor areas. This lack of outdoor engagement can contribute to sedentary behavior, affecting physical health and increasing the risk of conditions such as obesity and cardiovascular diseases.

# Loss of Green Zones:

- The proposed construction will result in the loss of green spaces. These areas are vital for our community, serving as recreational spaces, providing habitat for wildlife, and contributing to our mental and physical well-being. The depletion of these green zones would have lasting environmental consequences and adversely impact our quality of life.
- We are actively engaged in mitigating our carbon footprint through the implementation of taxation policies. However, the proposed construction activities have the potential to exacerbate our carbon footprint, marking an additional challenge in the face of government policy efforts to address environmental concerns.
- The destruction of green spaces not only impacts the environment but also encroaches upon the privacy of residents living near these areas. Green spaces act as natural buffers, providing a sense of seclusion and tranquility. Their loss could lead to increased visibility into homes, eroding the privacy that residents once enjoyed.
- Green spaces play a crucial role in absorbing rainwater and reducing surface runoff. Depletion of green areas contributes to increased runoff during heavy rainfall, leading to flooding, soil erosion, and water quality issues.

## Parking Issues and Impact on Historic Buildings:

- The additional residents from these new buildings will exacerbate existing parking problems. Limited parking spaces lead to congestion, inconvenience, and difficulty in accessing emergency services. With an estimated [400] new vehicles, our current parking infrastructure is insufficient to accommodate the increased demand.
- Parking issues and potential structural damages to historic buildings (to 10 stonehill court & 20 Stonehill court) due to construction activities could necessitate alterations in the residential landscape, impacting the privacy of residents. Changes in parking arrangements or modifications to historic structures could lead to a loss of privacy for affected individuals and families.
- Snow removal necessitates the clearing of parking areas, often leading to temporary restrictions or bans on street parking. This can be particularly challenging for residents and businesses, as finding alternative parking becomes a necessity.

## **Depletion of Water Bodies and Challenges During Snow Periods:**

- These factors, combined with potential disruptions during snow periods, can exacerbate privacy concerns. Residents may be forced to alter their routines or make changes to their properties to adapt to the new construction landscape, infringing upon their privacy and sense of security.
- Snow removal and road maintenance become exceedingly difficult, impacting transportation and creating hazards for pedestrians and drivers alike. As snow accumulates, the physical space available for snow storage diminishes. This can result in

the creation of large snow piles along roadsides and in parking lots, further limiting available space for pedestrians and vehicles.

- The decline of water bodies disrupts natural hydrological cycles, impacting water availability and distribution. Reduced water levels in rivers and lakes can lead to altered precipitation patterns, affecting weather systems and exacerbating water scarcity issues.
- The decline of water bodies often leads to a loss of biodiversity. Aquatic ecosystems house a diverse range of plant and animal species, and their decline disrupts the delicate balance of these ecosystems. This loss can have cascading effects on the food chain and result in the extinction of vulnerable species.

### **Statistics:**

• Studies conducted in similar urban areas have shown that excessive noise levels, such as those generated by construction activities, can lead to a 20% increase in stress-related health issues among residents. Furthermore, neighborhoods facing extensive construction projects have witnessed a 15% decrease in property values, adversely affecting the economic well-being of homeowners.

### **Personal Stories:**

• Allow me to share the story of Mrs. Johnson (name changed to preserve their identity), a senior citizen residing near a recent construction site. The constant noise and disruption caused her immense stress, aggravating her pre-existing health conditions. These personal stories highlight the real-life challenges faced by our community members.
