

## **Realignment of Permit Parking Area 7B to Exclude the Development Located at 550 Adelaide Street East**

### **SUMMARY**

---

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to respond to City Council's direction to review and report back on the realignment of Permit Parking Area 7B to exclude the development located at 550 Adelaide Street East.

Staff have determined the realignment of the Permit Parking Area 7B is feasible and has no objections to excluding the development located at 550 Adelaide Street East. If City Council excludes this address from the subject Permit Parking Area, residents and visitors of this address will be prohibited from participating in the on-street permit parking program.

### **RECOMMENDATIONS**

---

The Director, Permits and Enforcement, Transportation Services recommends that:

1. Toronto and East York Community Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of Permit Parking Area "7B", as shown in Attachment 1 of the report dated August 25, 2023 from the Director, Permits and Enforcement, Transportation Services, excluding the development currently located at 550 Adelaide Street East.

## **DECISION HISTORY**

---

At its meeting of July 19, 2023, City Council adopted item TE6.19, and in so doing, requested Transportation Services to examine and report back regarding the realignment of Permit Parking Area 7B to exclude the development address of 550 Adelaide Street East.

## **COMMENTS**

---

Transportation Services received a request from City Council, TE6.19 to realign Permit Parking Area 7B, to exclude the development located at 550 Adelaide Street East.

Permit Parking Area 7B is bounded by Sherbourne Street to the west, Parliament Street to the east, Front Street East to the south and Queen Street East, Seaton Street and Ramsay Lane to the north. Area 7B has 36 on-street parking spaces. To date 36 permits have been issued. This area has a history of being waitlisted, meaning the demand for overnight on-street parking permits exceeds the supply of parking spaces.

A map of Permit Parking Area 7B is included in Attachment 1.

The exclusion of the development located at 550 Adelaide Street East is a means to ensure that current permit holders have sufficient parking space. The issuance of parking permits to residents, guests, tradespeople and caregivers of this development would negatively impact on the already limited parking supply in the neighbourhood.

A Public Notice was placed on the City's website requesting those objecting to the exclusion of 550 Adelaide Street East from permit parking in Permit Parking Area 7B forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting.

The exclusion of this address from the subject Permit Parking Area will mean residents and visitors of this address will be prohibited from participating in the on-street permit parking program.

Transportation Services has no objections to the exclusion of 550 Adelaide Street East from Permit Parking Area 7B.

The Ward Councillor has been advised of the recommendation in this report.

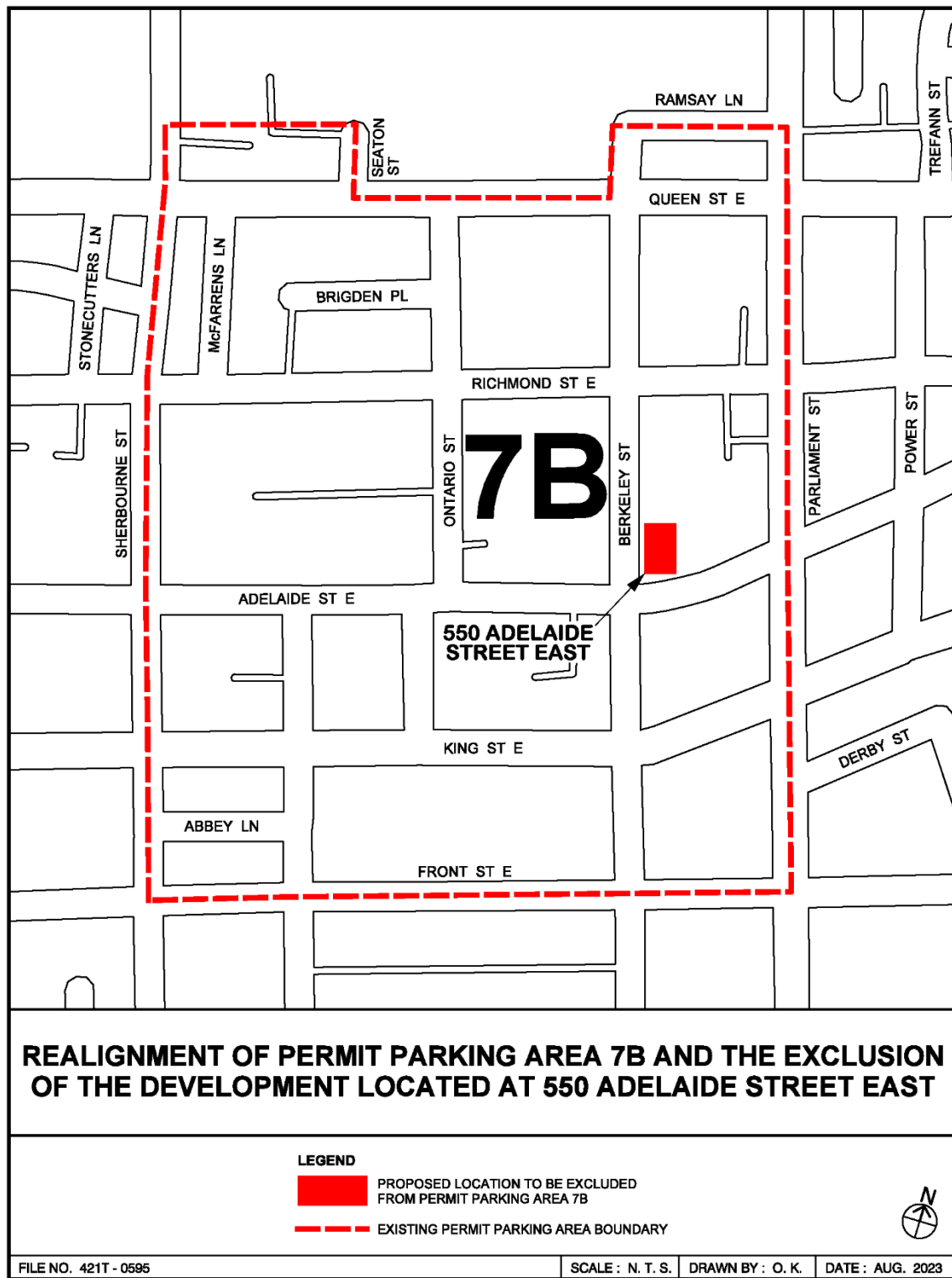
