Dear Warren Park Community and City of Toronto,

Our school, Humbercrest Public School, is working towards TDSB's goals, including Goal 5 "Build strong relationships and partnerships within school communities to support student learning and well-being."

Humbercrest PS students use St. Mark's Road and hill daily to get to and from school. Humbercrest PS receives students from grades JK-8 and all Warren Park JPS for grades 7 & 8. In addition, students accessing Warren Park Outdoor Centre and general curriculum-linked nature programming accessing Etienne Brule Park also must use the hill to get to and from these educational opportunities.

Safe pedestrian access between the local community and Humbercrest Public School is an important part of ensuring the well-being of all our students. St. Mark's Road between Humbercrest Blvd. and Varsity Road offers sub-standard walking conditions presenting risks to our community of students and negatively impacting our students safety and wellbeing, particularly in the winter months. We are concerned about the prevalence of cars losing control and sliding onto the sidewalk and the lack of visibility for students crossing at the bottom of the hill.

Dear Warren Park Community and City of Toronto,

As a TDSB school, student safety and wellness play an important role in offerings to our school community.

A sizeable portion of our student population and a number of staff members live in the Warren Park neighbourhood. In order to travel to and from our school daily on foot the only reasonable route requires walking along St. Mark's Rd from Varsity Rd. to Humbercrest Blvd, otherwise known as St. Mark's Hill, a route that our staff, parent council, and families have identified as a safety risk and impediment to walking.

As an EcoSchools Canada participant, we're actively working on increased environmental awareness school-wide, including low-carbon commuting. Safety concerns on St. Mark's Road reduce the number of families and staff that are willing to travel to school by walking, therefore increasing the environmental impact our school community has locally and globally.

Our school has a limited capacity to handle vehicular traffic at student drop-off and pick-up times, and increased vehicles on site also pose an increased risk to students. These conditions further motivate us to pursue walking as a preferred means of travel for our students over driving.
