Contract is expected to start on date of award and end on December 31, 2024.

FINANCIAL IMPACT

The total contract award identified in this report is \$2,587,106 net of all applicable taxes and charges, \$2,923,430 including all applicable taxes and charges. The cost to the City is \$2,632,639 net of HST recoveries.

The engineering estimate for this project is \$3,017,568 net of all taxes and charges.

Funding is included in the 2024 Capital Budget Submissions of Transportation Services. Additional funding details follow in Table 1.
