Contract Award Value:

\$9,017,019 net of all applicable taxes and charges \$10,189,231 including HST and all applicable charges \$9,175,719 net of HST recoveries

Contract is expected to start on date of award and end on December 18, 2025.

FINANCIAL IMPACT

The total contract award identified in this report is \$10,189,231 including all applicable taxes and charges. The cost to the City is \$9,175,719 net of HST recoveries.

The engineering estimate for this project is \$9,560,793 net of all taxes and charges.

Funding is included in the 2024 Capital Budgets and 2025-2033 Capital Plans for Toronto Water and Transportation Services. Funding details are summarized in Table 1 as follows:
