## **Proposed Changes to User Fees**

Toronto City Council will be considering recommendations to pass by-laws to amend the City of Toronto Municipal Code Chapter 441, Fees and Charges, so as to adopt changes to existing user fees and new user fees. Changes to existing user fees and new user fees are proposed in the Prepared 2024 Rate and Tax-Supported Budget. The Mayor's proposed 2024 Rate and Tax-Supported Budget will be considered by City Council on February 14, 2024.

While the Prepared 2024 Rate and Tax-Supported Budget includes revenues from the recommended fees, Toronto City Council may adopt rates that differ from them, including fees that are higher or lower, and may adopt new fees not contemplated in the Prepared Budget.

The City of Toronto Act, 2006 and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees. If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.
