2024 OPERATING BUDGET BRIEFING NOTE Cost-Recovery for Short-Term Rental Fees

Issue/Background:

 On January 18, 2024, Budget Committee requested a briefing note on the change in short-term rental registration fees necessary for the program to operate on a costrecovery basis.

Key Points:

- Toronto Municipal Code Chapter 547 regulates short-term rentals in Toronto and requires short-term rental companies and short-term rental operators to be licensed and registered by the City.
- The primary goals of Chapter 547 are to limit short-term rental activity in Toronto to principal residences and to protect critical rental stock by maintaining access for tenants to long-term accommodation.
- Since Chapter 547 came into effect in 2020, over 17,000 applications for short-term rental registrations have been made. There are currently 2 short-term rental companies licensed and 8,202 operators registered with the City.
- In 2024, direct costs to administer and enforce Chapter 547 are projected to be \$2,842,773. Revenue is projected to be \$1,861,208, representing a 65.5% cost recovery for the program budget.
 - There are currently 17 FTEs, including enforcement staff, compliance and audit staff and licensing administration staff dedicated to the program.
 - The number of staff required to administer and enforce the by-law exceeds the resourcing needs that were estimated when Chapter 547 was adopted in 2017.
- To bring the program up to cost recovery, the per night fee paid by short-term rental companies should be increased to \$1.92 (from \$1.10). See Table 1 for details.
- Staff will be reporting to the February 28, 2024 meeting of Planning and Housing Committee on an implementation review of Chapter 547. The report will include a review of user fees and additional resource requirements needed to enhance enforcement and compliance with the Chapter.
