

Supplementary Report - Increase in Penalty Amounts for Parking Offences

SUMMARY

The purpose of this report is to provide more details on 125 select 'Parking', 'Standing' and 'Stopping' offences being considered for increases in penalty amounts.

RECOMMENDATIONS

DECISION HISTORY

This report addresses a request made by the Infrastructure and Environment Committee on February 27, 2024.

COMMENTS

The Infrastructure and Environment Committee, who met on February 27, 2024, requested that a more detailed table of information be prepared that shows a direct comparison of the current penalty amounts to the proposed new penalty amounts for each parking offence being considered for an increase.

Attached to this report is a table of the penalty increase amounts for 125 select 'Parking', 'Standing' and 'Stopping' offences under Municipal Code Chapters 886, 910, 918, 925, 950 & Exhibition Place. The table is broken down by Municipal Code Chapter and under each offence type the current and proposed penalty amount is shown, including the highest penalty amount found in one other jurisdiction (where available), the rationale for the increase and the year the penalty amount was last updated.

Rationale for Increases fall under one or more of the following categories:

- i) ‘Penalty Amount Low’ – amount greater in some jurisdictions.
- ii) ‘Compliance’ - Number of parking infractions issued continue to be high or trending upward.
- iii) ‘Safety’ - offence is more serious and poses safety concern.
- iv) ‘Alignment’ - align penalty amount with those within the same category (i.e., an increase to one or more types of ‘No Stopping’ infraction should be consistent).
