REASON FOR CONFIDENTIAL INFORMATION

This report is about litigation or potential litigation that affects the City or one of its agencies or corporations.

SUMMARY

On December 10, 2020, an application to amend the Zoning By-law was submitted to permit the construction of a 12-storey residential building containing 158 dwelling units with condominium tenure. The application was deemed complete on December 15, 2020.

On March 21, 2023, a revised Zoning By-law Amendment application was received. This application proposes to redevelop the lands with a 29-storey residential building containing 296 dwelling units and an approximate gross floor area of 20,761 square metres and 8.2 FSI.

On August 14, 2023, the applicant appealed the Zoning By-law Amendment application to the Ontario Land Tribunal ("OLT") due to City Council not making a decision within the 90-day time frame specified in the *Planning Act.*

The City Solicitor requires further direction for the upcoming OLT hearing.

RECOMMENDATIONS

The City Solicitor recommends that:

1. City Council adopt the confidential instructions to staff in Confidential Attachment 1 to this Report from the City Solicitor.

2. City Council authorize the public release of the confidential recommendations in Confidential Attachment 1 and Confidential Appendix "A" and Confidential Appendix "B" to this Report from the City Solicitor, if adopted by City Council.

3. City Council direct that the balance of Confidential Attachment 1 to this Report, from the City Solicitor, remain confidential as it contains advice which is subject to solicitorclient privilege.

FINANCIAL IMPACT

There is no financial impact arising from the adoption of the Confidential Recommendations beyond what has already been approved in the current year's budget.
