#### Subject: Letter of Support for the Next Phase of Waterfront Revitalization

Addressing congestion is a pressing issue, and these measures must be part of a broader, evidence-based, system-wide approach to improving travel times across the city.

The importance of connectivity to the waterfront cannot be overstated. Expanding accessibility to this vibrant and growing area of the city presents significant opportunities to enhance economic activity and support thriving communities. For instance, accelerating access to the waterfront through the PATH network would bolster business operations and ensure seamless movement for workers and visitors.

### **Expanding Water Transportation**

Compared to other world-class cities, Toronto has yet to fully leverage the potential of its waterfront for water-based transportation. Expanding water transportation options for both people and goods is critical for enhancing connectivity, creating a memorable visitor experience, supporting the movement of goods in our region and enabling industrial uses on our waterfront to continue to thrive. We strongly support the establishment of a dedicated funding envelope to implement the 2020 Marine Use Strategy. Additionally, we advocate for bold, innovative initiatives to optimize the use of our water as a transportation, recreational and economic resource.

### **Continued Support for Waterfront Toronto**

Waterfront Toronto has consistently delivered on its mandate—a remarkable achievement for one of North America's largest revitalization initiatives. The organization's proven track record underscores the need to extend its mandate to ensure continuity and success in this next critical phase of development. The Toronto Region Board of Trade supports this extension.
