At its February 14, 2024 meeting, City Council approved the 2024 Capital Budget for TO Live (agenda item #114) with cash flows and future year commitments totaling \$42.119 million as detailed by project in Appendix 5a to the 2024 Staff Recommended Capital and Operating Budget Notes for TO Live.

At its December 12, 2023 meeting, the Board of Directors of TO Live approved all projects in TO Live's 10-year capital plan and budget, including those with multiyear components, and all related purchase orders and/or tender awards over \$100,000 up to each individual project budget, adjusted budget or new project budget, not to exceed the available State of Good Repair Council approved funding.
