Dangerous Act confirmed. Surfwave bit another dog, the bite and incident were deemed severe.

As a result of this Order, you must ensure the dog named above complies with the following conditions at all times as per section 349-15.1 of Municipal Code Chapter 349, Animals:

- 1. The dog must be muzzled at all times when off its owner's property;
- The dog is not permitted to enter into a designated leash-free area of a City park;
- 3. The dog must wear a dangerous dog tag which the owner has purchased from the City:
- 4. The owner must post awarning sign in the following location(s): FRONT OF PROPERTY
- 5. The dog must be microchipped within 14 days of this order;
- 6. The dog owner must provide a photograph of the dog to the City; and
- 7. The dog must receive training within 90 days of this order, and proof of completion must be sent to the City within 14 days of completion.

In accordance with section 349-16 of Municipal Code Chapter 349, Animals, you may appeal this Order to the Dangerous Dog Review Tribunal within 30 days of the date of service noted below. Details on how to make an appeal can be found on the reverse of this form. Please note that you must continue to comply with this Order until the Dangerous Dog Review Tribunal hears and decides your appeal.

Appeal of order

An owner who has been served with a Dangerous Dog Order under section 349 -16 of Chapter 349 of the Toronto Municipal Code, may apply for a hearing to the Dangerous Dog Review Tribunal to appeal an officer's determination of a dangerous dog.

Appeal Procedure

The request for appeal form and the appeal fee must be received by the City no later than 30 days after the date the Dangerous Dog order was served on the dog owner.

Failure to file an appeal within this time limit will result in the request for appeal being rejected. This form must be submitted, along with the appeal fee **by registered mail** to the following address:

The non-refundable appeal fee must be submitted by certified cheque, money order or bank draft, payable to Treasurer, City of Toronto.
