margin. The Candidate has run in elections for close to two decades and would be well aware of the governing laws and record keeping expectations.					
(1) Corporate Discounts and Donations: Candidate submitted evidence of significant overspending via corporate discounts. Typically, discounts should be represented as in-kind contributions from an individual and must follow the same restrictions on maximum contributions by an individual, and expenses must be captured at full market value in bookkeeping. The Candidate was in violation of the MEA in several instances and has clearly exceeded the spending limit.					
(2) Improper classification of campaign event expenses as fundraising event expenses: Candidate has claimed significant expenses for campaign events that have been improperly classified as fundraising events. These expenses should be counted towards the general spend limit as opposed to outside of the spend limit.					
(3) Extent of further overspend is presently difficult to verify due to the Candidate failing to submit valid invoices for all expenses to Toronto City Clerk. Candidates are required to keep receipts of all expenses under the MEA, and must submit copies of all invoices to Toronto City Clerk to participate in Toronto's Contribution Rebate Program. These missing invoices represent substantial spending relating to office expenses, consulting services, advertising, additional literature, web development/digital services, election signs, and more. These missing invoices represent several violations of both the MEA and Toronto Contribution Rebate Program by-law and a compliance audit is necessary to determine the extent of the violations.					
The above serious inconsistencies and instances of probable overspending demonstrate a compliance audit is warranted to protect the integrity of elections in the City of Toronto.
