## Independent Auditor's Report

### Qualified Opinion

I have audited the accompanying financial statement (Form 4) of Parthi Kandavel, candidate, for the campaign period from September 7, 2023, to January 15, 2024, relating to the election held on November 30, 2023, and Box C: Statement of Campaign Period Income and Expenses for the period and Box D: Calculation of Surplus of Deficit. The financial information has been prepared by Parthi Kandavel, the candidate, in accordance with the financial reporting provisions of Section 88.8 through 88.32 of the *Municipal Elections Act, 1996*.

In my opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion section of my report, the accompanying financial statement presents fairly, in all material respects, the income and expenses of Parthi Kandavel for the campaign period September 7, 2023, to January 15, 2024, in accordance with the financial reporting provisions of Section 88.22 of the *Municipal Elections Act, 1996*.

### Basis for Qualified Opinion

Due to the inherent nature of the transactions of electoral campaigns of this type, the completeness of the various categories of income and expenses is not susceptible to satisfactory audit verification. Accordingly, my verification of these income and expenses was limited to the amounts recorded in the accounting records of Parthi Kandavel. Therefore, I was not able to determine whether any adjustments might be necessary to income, expenses, and surplus/deficit for the period September 7, 2023 to January 15, 2024.

I conducted my audit in accordance with Canadian generally accepted auditing standards ("Canadian GAAS"). My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statement section of my report. I am independent of Parthi Kandavel, in accordance with the ethical requirements that are relevant to my audit of financial statements in Canada, and I have fulfilled my other ethical responsibilities in accordance with these requirements. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified opinion.

### Basis of Accounting

Without modifying my qualified opinion, I draw your attention to the basis of accounting of the Financial Statement, which is presented in Form 4 as prescribed under the *Municipal Elections Act, 1996*. As a result, the Financial Statement may not be suitable for another purpose.



### **Responsibilities of the Candidate and Those Charged with Governance for the Financial Statement**

The candidate is responsible for the preparation of the Financial Statement in accordance with the provisions of sections 88.8 through 88.32 of the *Municipal Elections Act, 1996* and for such internal control as the candidate determines is necessary to enable the preparation of the financial statement that is free from material misstatement, whether due to fraud or error.

### **Auditor's Responsibilities for the Audit of the Return**

My objectives are to obtain reasonable assurance about whether the financial statement as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial statement.

As part of an audit in accordance with Canadian generally accepted auditing standards, I exercise professional judgment and maintain professional skepticism throughout the audit.

I also:
