# **TO Live**

## Update on the Fundraising for the St. Lawrence Centre Redevelopment Project

TO Live is committed to securing the revenues needed to complete the St Lawrence Centre Redevelopment project. (NEW STLC) from three sources;

- Government (Federal, Provincial, Municipal)
- Corporate and Philanthropic investments
- Fundraising Campaign (Capital Fundraising campaign)

#### **Government Relations**

TO Live engaged **Crestview Strategy consultants** to assist in providing information to the Provincial and Federal Governments regarding the NEW St Lawrence Centre.

Building upon the International Design Competition and City Council's support, Crestview and TO Live emphasized the project's viability and longevity, highlighting its profound significance for Toronto's cultural corridor while aligning with federal and provincial mandates. The overarching goal was to secure interest from both levels of government, marking a pivotal phase in advancing the NEW STLC Project. TO Live, with the support of Crestview Strategy, participated in pre-budget consultations, mobilized champions, and had conversations with key MPs and MPPs.

#### **Federal Government**

TO Live positioned the NEW STLC as a major infrastructure project, emphasizing the project as an iconic investment for the Liberal 416 Caucus. Also, anticipating a forthcoming election, we engaged in outreach to relevant Conservative Members of Parliament, specifically targeting Shadow Ministers responsible for related portfolios. This approach aimed to establish meaningful relationships with key decision-makers within the party, safeguarding the advancements achieved to date.

#### **Provincial Government**

The NEW STLC was positioned as the gateway to Ontario's cultural corridor in our engagement with the provincial government. Situated strategically along the Ontario Line, it will anchor an expansive corridor from Cork Town to Ontario Place. We identified the project as a redefined cultural corridor to become a tourism and economic development engine, elevating Toronto as a cultural destination enhancing. The NEW STLC was positioned as a vital Toronto infrastructure investment.

#### **Corporate and Philanthropic Fundraising**

The NEW STLC and District is a significant opportunity for a Corporate or Philanthropic Partner and unique in the Country for it's location and level of recognition.

#### An example of a comparable project and Naming Opportunity

In Calgary, the Arts Commons Transformation project is reimagining a modern civic arts campus. This project is a comprehensive investment in an entire city block and an enhancement of Calgary's cultural identity. Much like TO Live's Cultural District redevelopment, the Arts Commons is a transformational civic infrastructure undertaking with a focus on culture and community. It is a collaboration between government,

corporate, and private sectors. Following a landmark \$75M philanthropic gift (the largest of its kind in Canada), the building will be renamed the Werklund Centre.
