SUMMARY

The purpose of this staff report is to report on the refusal to issue a permit by Municipal Licensing & Standards in the matter of an application for Clothing Drop Box Location permit at 2020 Sheppard Ave West.

RECOMMENDATIONS

The Director of Business Licensing and Regulatory Services, Municipal Licensing & Standards recommends that:

1. City Council deny the application for the proposed Clothing Drop Box Location permit at 2020 Sheppard Avenue West.

OR

2. City Council approve the application for the proposed Clothing Drop Box Location permit at 2020 Sheppard Avenue West.

FINANCIAL IMPACT

There are no financial implications resulting from the adoption of this report.

DECISION HISTORY

This is a new application for a clothing drop box permit located at 2020 Sheppard Avenue West.

COMMENTS

An application for a clothing drop box located at 2020 Sheppard Avenue West was received on January 1, 2024 from the business owner representing Green Earth Used Clothing Recycling Inc. operating as Green Earth Used Clothing Recycling Inc.

This application meets the physical criteria for a clothing drop box location permit, as set out in Chapter 395 of the City of Toronto Municipal Code.

The City of Toronto Municipal Code, Chapter 395-2 Subsection B.1 (2) indicates: If the Executive Director refuses to grant a permit under this section, the applicant shall be notified in writing and advised that they may appeal the decision to the community council which has jurisdiction for the location of the proposed event or activity by filing an appeal within 21 days of the date of the notice.

A written objection from the Ward Councillor was received by Municipal Licensing & Standards on February 8, 2024.

A refusal letter was sent on February 8, 2024 to the business owner, advising the applicant that an objection was received and that the clothing drop box location permit application was denied.

On February 14, 2024 a letter was received by Municipal Licensing & Standards from the business owner, to appeal the decision of the denial for a clothing drop box location permit.
