Award of Province of Ontario's Vendor of Record (VOR) Tender Number 19514 to Qualified Manufacturers, Their Authorized Dealers and Upfitters, for Supply and Delivery of Various Vehicles under Category 1, 2 and 3 – General Vehicle Acquisition and Upfitting Services for Fleet Services Division

SUMMARY

The purpose of this report is to seek authority for the General Manager of Fleet Services Division (FSD) to utilize Province of Ontario's Vendor of Record (VOR) Arrangement Tender Number 19514 (Vehicle acquisition and upfitting services), between Centralized Supply Chain Ontario ("Supply Ontario") and the following qualified vendors: Ford Motor Company of Canada Limited, General Motors of Canada Company, FCA Canada Inc., Toyota Canada Inc., and their authorized local dealers under Category 1 - General Vehicle Acquisition Including Police/Special Service Enforcement Vehicles; with Action Car and Truck Accessories Inc., G.W. Anglin Manufacturing Inc., 1000164110 Ontario Inc. These agreements will be effective for a fixed period of four (4) years from date of award to June 30, 2028, with a total consolidated value of \$181,691,529 net of all applicable taxes and charges (\$184,889,301 net of Harmonized Sales Tax recoveries), in accordance with the terms, conditions, and specifications set forth in the VOR and applicable City policies.

The vehicle acquisition and upfitting services detailed in this report aims to support a range of city divisions, agencies, and corporations. This encompasses essential services such as Toronto Paramedics, Toronto Fire Services, the Toronto Zoo,

Exhibition Place, the Toronto Transit Commission's non-revenue fleet, and the Toronto Parking Authority.

Section 195-6.6 of Toronto Municipal Code Chapter 195 (Procurement), permits a procurement be made directly from a supplier of another public body, if the Chief Procurement Officer determines that the public body followed a competitive method consistent with the City of Toronto's procurement process.

RECOMMENDATIONS

FINANCIAL IMPACT

The total potential consolidated contract awards identified in this report is \$181,691,529 net of all applicable taxes and charges. The total potential consolidated cost to the City for the fixed term is \$184,889,301 net of Harmonized Sales Tax recoveries.

Funding in the amount of \$60,350,800 net of Harmonized Sales Tax recoveries is available in the 2024 Capital Budget and 2025-2033 Plan for Fleet Services Division. Additional funding in the amount of \$124,528,501 net of Harmonized Sales Tax recoveries will be included in the 2025-2034 Capital Budget and Plan Submission for Fleet Services Division. Spending will be limited to the budget availability within Fleet Services Division at the time expenditure and approval by the Division Head. Funding details are shown in Table 1 to Table 12.

COMMENTS

Background Summary:

Fleet Service Division's previously held contracts under VOR Arrangement Number OSS-00634452 with General Motors of Canada Company, FCA Canada Inc., PK Welding & Fabricators Inc., Weldexperts Inc., and Ford Motor Company of Canada Limited for the non-exclusive supply and delivery of various light-duty vehicles, including upfitting services. These contracts expired on June 30, 2024.

Current Need:

The Fleet Service Division requires new procurement arrangements following the expiration of previous contracts under VOR Arrangement Number OSS-00634452 with Ford Motor Company of Canada Limited, General Motors of Canada Company, FCA Canada Inc., Toyota Canada Inc., Action Car and Truck Accessories Inc., G.W. Anglin Manufacturing Inc., 1000164110 Ontario Inc. (Manufacturing & Technology Centre), Adrian Steel of Canada Inc., PK Welding & Fabricators Inc., and Weldexperts Inc. for several key reasons:

- 1. Replacement of Aging Vehicles: Many vehicles in the fleet have reached the end of their operational life and need replacement to ensure safety and reliability in service.
- 2. Addressing State of Good Repair (SOGR) Backlog: There is a pressing need to address the backlog of vehicles that require replacement to maintain operational efficiency. New acquisitions will help reduce downtime and improve service delivery.
- 3. Supporting Operational Needs: The acquisition of new light-duty vehicles, including sport utility vehicles (SUVs) and pickup trucks, is essential for various operational functions across different divisions and agencies, ensuring they can fulfill their mandates effectively.
- 4. Sustainability Goals: The new procurement will include electric vehicles where feasible, supporting the TransformTO goals and aligning with the province's commitment to reducing greenhouse gas emissions.
- 5. Continuity of Services: Ensuring that vehicle availability continues without interruption is vital for ongoing services that rely on the fleet. New contracts will facilitate this continuity.
- 6. Flexibility and Responsiveness: Establishing new agreements allows the Fleet Service Division to respond more effectively to changing operational demands and evolving needs of the divisions and agencies.

By entering into new agreements, the Fleet Service Division can ensure it meets its operational requirements while supporting sustainability initiatives and adhering to public service procurement regulations.

Procurement Process Overview:

The VOR Arrangement Number 19514 has been established between the Centralized Supply Chain Ontario operating as Supply Ontario and major vehicle manufacturers including Ford Motor Company of Canada, General Motors of Canada Company, FCA Canada Inc., and Toyota Canada Inc. This arrangement is designed to meet the vehicle needs for all ministries within the Government of Ontario.

Below are Categories Under VOR Arrangement Number 19514

- 1. Category 1 General Vehicle Acquisition Including Police/Special Service Enforcement Vehicles
 - Encompasses the acquisition of various vehicles, including passenger, light commercial, and police/special service enforcement vehicles.
 - Mandatory for all Ontario Public Service (OPS) ministries and agencies, regardless of procurement value.
- 2. Category 2 General Vehicle Upfitting and Accessories
 - Includes the upfitting of a wide range of vehicles, such as emergency response vehicles and highway maintenance trucks.
 - Mandatory for all OPS ministries and agencies.
- 3. Category 3 Custom Vehicle Fabrication
 - Covers vehicles that require customization, including those for emergency management, prisoner transport, ambulances, and mobile command units.
 - Mandatory for all OPS ministries and agencies.

Vehicle Ordering Models:

The VOR 19514 provides three (3) distinct ordering models to facilitate procurement:

- 1. Option 1 Direct Ordering Model
 - Upon receipt of the Purchase Order, the Vendor assigns a delivering dealer.
 - The vendor provides the order information to the dealer.
 - The dealer supplies the license plate and proof of delivery to the Client.
 - The client communicates licensing and delivery instructions to the dealer.
 - The vendor submits the invoice to the Client for payment.
- 2. Option 2 Indirect Ordering Model

The indirect ordering model is preferred by the client only if the Vendor is required to fulfill orders through its dealer network and invoicing must be between the client and the dealer.

- Upon receipt of the Purchase Order, the vendor assigns a delivering dealer.
- The vendor indicates the pricing structure and criteria for invoicing to the dealer.
- The dealer generates the invoice and sends it to the Client.
- The client communicates licensing and delivery instructions to the dealer.
- The client arranges payment of the invoice directly to the dealer.

3. Option 3 - Fleet Management Services Vendor (FMSV) Ordering Model

Where the Vendor does not provide a direct ordering service and the indirect ordering model, the Client provides all vehicle specifications and upfitting requirements to the FMSV.

- This ordering model does not apply to the city.

Responsibilities:

Vendor Responsibilities

- Provide status updates on vehicle orders, including dealer information.
- Ensure all orders are processed through the Vendor's dealer network.

City Responsibilities

- Receive proof of delivery before making any payments for vehicle orders.

Next Steps:

The Fleet Services Division will assess which ordering model best suits their needs and proceed with establishing contracts with local authorized dealers. A comprehensive timeline will be developed to ensure efficient communication and procurement processes, aligning with operational requirements and sustainability goals.

Benefits to Operations from New Procurement Arrangements:

- 1. Enhanced Vehicle Reliability: New vehicles reduce the risk of breakdowns and maintenance issues, ensuring that operational functions can be carried out smoothly and efficiently.
- 2. Improved Safety: Up-to-date vehicles come equipped with the latest safety features, enhancing the safety of personnel who rely on these vehicles for their duties.
- 3. Increased Efficiency: Modern vehicles often have better fuel efficiency and performance capabilities, leading to lower operational costs and improved productivity.
- 4. Support for Diverse Operational Needs: By acquiring a variety of vehicles, including light-duty trucks and electric options, the Fleet Services Division can better meet the specific needs of different divisions and agencies, allowing for more tailored and effective service delivery.
- 5. Sustainability and Environmental Compliance: Including electric vehicles aligning with sustainability goals, helping the organization reduce its carbon footprint and comply with environmental regulations and public commitments.
- 6. Addressing Backlog Issues: By replacing aging vehicles, the procurement will help alleviate the backlog of vehicles in need of replacement, allowing for more streamlined operations and fewer service disruptions.
- 7. Operational Flexibility: The ability to select from a range of vehicles and upfitting options provides operational flexibility, allowing divisions and agencies to adapt to changing needs and priorities more quickly.
- 8. Cost Management: New procurement contracts can lead to more favorable pricing and terms, helping manage the overall budget for fleet operations more effectively.

- 9. Streamlined Processes: The use of established vendor agreements simplifies the procurement process, allowing for quicker acquisition of vehicles and reducing administrative burdens.
- 10. Support for Emergency Services: Ensuring that emergency response vehicles are reliable and up-to-date is crucial for public safety and effective emergency management.

By implementing these new procurement arrangements, the Fleet Service Division will enhance its operational capacity, improve service delivery, and contribute to the overall goals of the Ontario Public Service.

The VOR Arrangement Number 19514, for the supply and delivery of various light duty vehicles and upfitting services, custom fabrication was issued by Province of Ontario on May 9, 2024. There were eight (8) Addenda issued. Solicitation was closed on June 17, 2024, resulting on five (5) bids under Category 1, eight (8) bids under Category 2 and five (5) bids on Category 3.
