

Dear Toronto Board of Health Members,

Re: Agenda Item 2 – Appointment of Medical Officer of Health

Given that Board members rely heavily on the Medical Officer of Health for scientific and policy advice, selecting the next Medical Officer of Health is a very important task that will largely impact the health of the citizens of Toronto going forward.

My hope is for a Medical Officer of Health that will be open-minded when it comes to listening to what I and others have been sharing over the course of the Covid-19 pandemic, in particular with regards to the harms of the Covid-19 mRNA vaccines. Dissident voices, in particular, the many scientists that are speaking up against the Covid-19 mRNA vaccines around the world are critical to listen to. In Canada, we have the [Canadian Covid Care Alliance](#), a volunteer-run organization with over 700 Canadian physicians, researchers, healthcare practitioners, and legal & ethical professionals.

As well, I hope for a Medical Officer of Health that would independently assess the appropriateness of directives from the W.H.O., federal agencies, and the provincial Minister of Health. Authorities make mistakes or can be politically motivated or have ties to Big Pharma. We need a Medical Officer of Health who will take information from these authorities, and critically assess if it's good for the health of Torontonians. If not sure, he or she could implement a best option "A" but carefully check if "A" actually works, by listening to citizens and examining local data, and pausing and readjusting if called for.

Action at the local level is so important. Increasingly in different parts of the world, local councils are pushing back against the Covid-19 mRNA vaccines:

- In Australia, the local council of Port Hedland passed a motion last month calling for a halt to the Covid-19 mRNA vaccines due to DNA contamination 145 times the safety limit, which poses significant potential health risks, including genomic integration, development of cancers, and immune system disruption. This DNA contamination was measured by Ontario scientist David Speicher who tested Australian vials of Pfizer and Moderna. For more info, go to <https://porthedlandmotion.info/>
- In Idaho, also last month, the Southwest District Health Board voted to halt Covid-19 mRNA vaccine distribution in its health clinics, following weeks of public commentary and presentations by health experts. The Covid-19 mRNA "vaccines" are actually novel gene therapies with too many unknowns, the clinical trials skipped important steps and were fraught with fraud, and the vaccine adverse event reporting system that we have is grossly underestimating harms. Local public health agencies and the Medical Officer of Health do not have to blindly follow federal agencies. They have the power and the moral obligation to protect their constituents.
