

Increase in Penalty Amounts for Parking Offences and Establishment of New Electric Vehicle Parking Offences for Off-Street Parking Facilities

Date: February 12, 2024

SUMMARY

This report responds to a request from the Infrastructure and Environment Committee to undertake a comprehensive review of the various on-street parking administrative penalty amounts and to report back on revised administrative penalty amounts.

Transportation Services has been working with a number of City agencies to review the Parking Violation Notices (PVN) issued by the City of Toronto and has conducted a jurisdictional scan of several Canadian municipalities to compare similar offences and their penalty amounts to those of the City of Toronto. As a result of this review, this report recommends Council approval to increase penalty amounts for 123 offences associated with 'parking', 'stopping' and 'standing'. The recommended increase in penalty amounts will ensure better alignment with penalty amounts in other jurisdictions, encourage compliance, ensure certain offences are set at levels commensurate with the seriousness of the offence, and ensure that offences within the same categories are set at the same penalty amount for consistency.

City of Toronto Municipal Code Chapter 610, Penalties, Administration of, will need to be amended to reflect the new penalty amounts.

This report also recommends establishing parking offences for electric vehicle charging parking stalls in off-street parking facilities as well as adding new or updating existing definition(s) related to Electric Vehicles ("EVs").

Currently, operators of off-street parking facilities, including the Toronto Parking Authority (TPA), have limited enforcement capabilities concerning EV parking due to a lack of offence provisions in the City of Toronto Municipal Code concerning parking in portions of parking facilities set aside for the charging of EVs. This absence of regulatory provisions restricts parking facility operators from ticketing non-EV's parking

in designated EV charging spaces, or ticketing EVs parked in designated EV charging spaces that are not actively charging.

The General Manager, Transportation Services, has consulted with the TPA as well as with operators and customers of off-street parking facilities which are regulated by Chapter 915.

As a result of the consultation by the General Manager, Transportation Services, and general observations concerning the needs relating to a positive customer experience for EV charging customers, this report is recommending amendments to the City of Toronto Municipal Code Chapter 950, Traffic and Parking, and City of Toronto Municipal Code Chapter 915, Parking on Private or Municipal Property, to introduce new offence provisions related to electric vehicle charging parking. This would allow the enforcement of the usage of off-street EV charging spaces and promote compliance. City of Toronto Municipal Code Chapter 610, Penalties, Administration of, will also need to be amended to reflect the new offence provisions and associated penalty amounts for the offence provisions.

RECOMMENDATIONS

The General Manager, Transportation Services, recommends that:

1. City Council amend City of Toronto Municipal Code Chapter 610, Penalties, Administration of, increasing the penalty amounts generally as outlined in Attachments 3 and 4 of this report (February 12, 2024) from the General Manager, Transportation Services with an implementation date of August 1, 2024.

2. City Council amend Section 950-101B of City of Toronto Municipal Code Chapter 950, Traffic and Parking, by:

a. deleting the phrase: "is equipped to receive a Level 2 SAE J1772 Conductive Charge Coupler (i.e., Level 2 charging capability)" such that the revised definition would read:

"ELECTRIC VEHICLE - A vehicle that has an electric motor that can be powered by drawing current from rechargeable storage batteries or other portable electrical energy storage devices, includes a plug-in hybrid vehicle, and for the purposes of recharging its batteries."; and

b. inserting in alphabetical order a new definition for ELECTRIC VEHICLE PARKING SPACE as follows:

"ELECTRIC VEHICLE PARKING SPACE - that portion of which is identified for parking use by an Electric Vehicle."

3. City Council amend Section 950-601 of City of Toronto Municipal Code Chapter 950, Traffic and Parking, to include a new Subsection S as follows:

"S. Where authorized signs to that effect are displayed identifying an Electric Vehicle Parking Space, no person shall park a vehicle in an Electric Vehicle Parking Space in a car-park set out in Schedule XXXIV to § 950-1333 unless the vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station."

4. City Council amend Sections 950-1200B and 950-1201A by deleting the phrase "or 950-601P" and inserting the phrase ", 950-601P or 950-601S".

5. City Council amend Section 915-1 of City of Toronto Municipal Code Chapter 915, Parking on Private or Municipal Property, by inserting in alphabetical order a definition of ELECTRIC VEHICLE and a definition of ELECTRIC VEHICLE PARKING SPACE as follows:

"ELECTRIC VEHICLE - A vehicle that has an electric motor that can be powered by drawing current from rechargeable storage batteries or other portable electrical energy storage devices, includes a plug-in hybrid vehicle, and for the purposes of recharging its batteries.

ELECTRIC VEHICLE PARKING SPACE - that portion of which is identified for parking use by an Electric Vehicle."

6. City Council amend Section 915-2 of City of Toronto Municipal Code Chapter 915, Parking on Private or Municipal Property, to include a new Subsection D and E, as follows:

"D. Where the property owner or occupant has posted signs identifying an electric vehicle parking space, no person shall park or leave a motor vehicle in an electric vehicle parking space on municipal property unless the motor vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station.

E. Where the property owner or occupant has posted signs identifying an electric vehicle parking space, no person shall park or leave a motor vehicle in a parking space on private property unless the motor vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station."

7. City Council amend Sections 915-10B and 915-10C by deleting the phrase "or § 915-2B" where it appears and inserting the phrase ", § 915-2B, § 915-2D or § 915-2E".

8. City Council amend the definition of Electric Vehicle in Section 910-1A of City of Toronto Municipal Code Chapter 910, Parking Machines, Parking Meters and Mobile Only Zones, by deleting the phrase: "is equipped to receive a Level 2 SAE J1772 Conductive Charge Coupler (i.e., Level 2 charging capability)" such that the revised definition would read:

"ELECTRIC VEHICLE - A vehicle that has an electric motor that can be powered by drawing current from rechargeable storage batteries or other portable electrical energy

storage devices, includes a plug-in hybrid vehicle, and for the purposes of recharging its batteries."

9. City Council amend City of Toronto Municipal Code Chapter 610, Penalties, Administration of, generally as set out in Attachment 5 to the report (February 12, 2024) from the General Manager, Transportation Services.

10. City Council authorize the City Solicitor to introduce the necessary bills to give effect to City Council's decision and City Council authorize the City Solicitor to make any necessary clarifications, refinements, minor modifications, technical amendments, or by-law amendments as may be identified by the City Solicitor or General Manager, Transportation Services, in order to give effect to Recommendations 1 to 9, inclusive.

FINANCIAL IMPACT

Although the intent of the recommended increase in penalty amounts will ensure better alignment with penalty amounts in other jurisdictions, encourage compliance with the City's parking by-laws, ensure certain offences are set at levels commensurate with the seriousness of the offence and assist the City in regulating the flow of traffic, assuming the 2023 level of offence volumes, the City could collect an added \$62 million in revenue although it is expected that the actual revenue increase would be \$40 to \$50 million.

There is no financial impact to Transportation Services resulting from the adoption of the recommendations in this report.

The Parking Enforcement Unit (PEU) of Toronto Police Service will experience additional financial and operational impacts when the implementation of the parking penalty increases come into effect at the appropriate time. The PEU will need to align updated electronic parking enforcement e-ticketing software updates and when delivery is expected of manual parking tickets with the new penalty increases.

In addition, PEU will require \$150,000.00 in additional City funds in 2024 to purchase approximately 400,000 parking tickets to update their current manual parking stock. The current stock that will be outdated with the old penalty amounts will not be usable by MLEO's, Police Officers and Parking Enforcement Officers when their electronic system is down.

The Chief Financial Officer and Treasurer has reviewed this report and agrees with the financial impact information.

DECISION HISTORY

City Council, at its meeting of October 11, 2023, adopted the General Government Committee Item GG6.25 entitled, "Increase in Parking Violation Notice Penalty Amount on Municipal / Private Property".

COMMENTS

Increases in Penalty Amounts for Parking Offences

Most penalty amounts have been left generally unchanged since their enactment and are not automatically adjusted for inflation. There have in recent years been some increases made in the penalty amounts for offences related to stopping and standing parking bylaws because of the seriousness of the offences in certain areas (e.g., parking in a rush-hour zone impacts traffic mobility more severely).

In reviewing comparable offences and their associated penalty amounts for surrounding municipalities, it was found that the majority of penalty amounts associated with the City of Toronto's various parking, standing, stopping offences, which are within the range of \$15 to \$60, were generally lower on average.

A cross-jurisdictional comparison of Canadian municipalities was undertaken to examine the penalty amounts for similar offences associated with 'parking', 'stopping' and 'standing' offences within the public right-of-way. This comparison revealed that the average penalty amounts for similar offences in these jurisdictions were generally found to be at a higher rate than the City of Toronto's current rates. Attachment 1, appended to this report, provides more details on some of the offences (i.e., not all) that were compared.

This report is recommending increases in penalty amounts for 123 different 'parking', 'stopping' and 'standing' offences. The City experienced a general increase in the number of Parking Violation Notices (PVNs) issued post-COVID; general parking and traffic offences trended upward over the last five-years. Attachment 2, appended to this report, highlights the more prevalent offences where PVNs have been issued, with amounts ranging from \$30.00 to \$100.00, for the years 2019 to 2023.

The table below shows 2019 to 2023 statistics on issued Parking Violation Notices for all offence types and the number of PVNs issued for those offences whose penalty amounts would be increased if the report recommendations are adopted.

The selection of the 123 different 'parking', 'stopping' and 'standing' offences for penalty amount increases was based on the following criteria:

- Current rate lower than those in other jurisdictions;
- Number of parking infractions issued continue to be high or trending upward (aim is to encourage compliance);
- Certain offences are more serious and pose safety concerns (e.g., stopped in bike lanes, parked in a Pedestrian Crossover (PXO), parking too close to an intersection which impacts sightlines, etc.); and
- Alignment of certain penalty amounts with those that are proposed for increase within the same category (i.e., an increase to one or more types of 'No Stopping' infraction should be consistent).

To implement the increases in penalty amounts for the various offences, Chapter 610, Penalties, Administration of, will need to be amended generally as outlined in Attachments 3 and 4.

Should the recommended penalty amounts in this report be adopted, the increased penalty amounts would take effect on August 1, 2024. The delay in implementation is to allow the Parking Enforcement Unit of the Toronto Police Service time to order new Parking Violation Notice books with the approved new penalty amounts.

The increased penalty amounts should reduce the number of illegal parking infractions and promote compliance.

New Electric Vehicle (EV) Charging Parking Offences for Off-Street Facilities

The Toronto Parking Authority (TPA) leads the City of Toronto's on-street and off-street EV charging programs. Enforcement of on-street parking rests with the Toronto Police Service, while enforcement of TPA off-street municipal parking facilities rests with the TPA.

Currently, operators of off-street parking facilities, including TPA, have limited enforcement capabilities around EV charging due to a lack of offence provisions in the City of Toronto Municipal Code concerning parking in portions of parking facilities set aside for the charging of EVs. This absence of regulatory provisions restricts parking facility operators from ticketing non-EV's parking in designated EV charging spaces, or ticketing EVs parked in designated EV charging spaces that are not actively charging.

Toronto Municipal Code Chapter 950 currently contains regulations preventing the parking of an "unauthorized vehicle" in a designated on-street EV parking space. This allows for the enforcement of this regulation by the Toronto Police Service when non-EV's parking in designated EV charging spaces or when EVs parked in designated EV charging spaces are not actively charging.

As part of the TPA's responsibilities to operate Municipal Parking Facilities, currently regulated under Municipal Code Chapter 950, the TPA has set aside portions of their facilities for EV charging. The TPA also enters into agreements for the operation and management of parking facilities with private landowners and some of these parking facilities, regulated by Toronto Municipal Code Chapter 915, Parking on Private or Municipal Property, may in future have portions of their lot set aside for EV charging.

Currently, the TPA operates 310 EV chargers in 29 off-street car-parks and plans to expand its profile of off-street EV charging facilities. In response to Transportation Services' consultation, the TPA reported that similar provisions to those which exist under Chapter 950 for purposes of regulating on-street EV charging would be useful with respect to the TPA's operation of a variety of differing off-street parking facilities.

The General Manager, Transportation Services, also consulted with private parking operators and customers of other off-street parking facilities regulated by Chapter 915. These consultations recognized that penalty provisions for EV charging at off-street parking locations should be consistent with on-street parking.

In response to the consultation, and general observations concerning the needs for a positive customer experience for EV charging customers, it is proposed that the City of Toronto Municipal Code provisions regulating various forms of off-street parking facilities be amended to allow for the ticketing of non-EV's parked in designated EV charging spaces, and ticketing of EVs parked in designated EV charging spaces that are not actively charging.

To support compliance, the General Manager, Transportation Services is recommending that Chapter 950 and Chapter 915 be amended to include new offence provisions prohibiting the parking of vehicles in EV parking spaces other than EVs actively engaged in a charging session. The penalty is proposed to be \$75.00, consistent with the recommended increased on-street EV penalty amount. The new offence provisions will generally read as follows:

Chapter 950, Section 950-601:

S. Where authorized signs to that effect are displayed identifying an Electric Vehicle Parking Space, no person shall park a vehicle in an Electric Vehicle Parking Space in a car-park set out in Schedule XXXIV to § 950-1333 unless the vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station.

Chapter 915, Section 915-2:

D. Where the property owner or occupant has posted signs identifying an electric vehicle parking space, no person shall park or leave a motor vehicle in an electric vehicle parking space on municipal property unless the motor vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station.

E. Where the property owner or occupant has posted signs identifying an electric vehicle parking space, no person shall park or leave a motor vehicle in a parking space on private property unless the motor vehicle is an Electric Vehicle and the Electric Vehicle is actively connected to the electric vehicle charging station.

These new proposed offence provisions are similar in language to the existing offence provision found as § 950-400I in Chapter 950 as it relates to parking unauthorized vehicles in on-street electrical vehicle charging station parking spots at various on-street parking locations.

In addition to creating the offence provisions, it is also recommended that the current definition of “Electric Vehicle”, as found in Chapter 950 and in Chapter 910 be amended, and a definition for “Electric Vehicle” be added in Chapter 915. The current definition of electric vehicle in Chapter 950 and in Chapter 910 dates to 2012 and is only applicable to Level Two electric vehicle charging capabilities. Since off-street facilities often include both Level Two and DC Fast Charging (sometimes referred to as Level Three), this report recommends that a broader definition of electric vehicle be used, that being:

A vehicle that has an electric motor that can be powered by drawing current from rechargeable storage batteries or other portable electrical energy storage devices, includes a plug-in hybrid vehicle, and for the purposes of recharging its batteries.

It is also recommended that a definition for Electric Vehicle Parking Space be inserted into Chapter 915.

Given that parking offences are dealt with under the administrative penalty regime at the City of Toronto, Chapter 610, Penalties, Administration of, must also be amended to reflect/designate the new offence provisions and provide penalty amounts. As noted in Attachment 6, the General Manager, Transportation Services, conducted a comparative analysis of the proposed penalty amount against the existing penalty amounts in Toronto for unauthorized vehicle in a designated electric vehicle charging on-street parking space currently contained in Municipal Code Chapter 950 and the fines/penalties applied in other Canadian municipal parking regimes. The proposed penalty amount for the new offence provisions is recommended to be \$75.00, which is consistent with those findings. The additional details on the amendments to Chapter 610 can be found in Attachment 5.
