The East Waterfront Community Association strongly supports the Under Gardiner Public Realm Plan (PRP) in its entirety, particularly its Lake Shore Boulevard East component (Secondary Study Area). We believe this plan offers a groundbreaking opportunity to revitalize the waterfront and improve the experience of residents, businesses, and visitors to our community.

Our association has a deep interest in the success of this project and is committed to enhancing our neighbourhood's connectivity, safety, and livability. The PRP's focus on improved northsouth connections aligns perfectly with our long-term goals of pedestrian and bicycle safety and security, peaceful enjoyment of the Lakefront, and family-friendly infrastructure. We've witnessed and participated in the East Waterfront's growth through our contributions to Community Liaison Committees, such as:

The PRP's recognition of the importance of coordinating this project with other major waterfront initiatives reassures us that there will be a cohesive and effective implementation.
