Notice was given and a Public Hearing was held on Thursday, August 15, 2024, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

Proposal to construct a new dwelling.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1.Chapter 10.20.30.40.(1)A), By-law No. 569-2013

The permitted maximum lot coverage is 30 % of the lot area.
The proposed lot coverage is 34 % of the lot area.

2.Chapter 10.20.40.10.(3)A), By-law No. 569-2013

The permitted maximum number of storeys is 2.
The proposed number of storeys is 3.

3.Chapter 10.20.40.10.(2)B)(ii), By-law No. 569-2013

The permitted maximum height of all side exterior main walls facing a side lot line is 7.5 m.
The proposed height of the side exterior main walls facing a west side lot line is 7.96m.

4.Chapter 10.20.40.10.(2)B(ii), By-law No. 569-2013

The permitted maximum height of all side exterior main walls facing a side lot line is 7.5 m.

The proposed height of the side exterior main walls facing an East side lot line is 8.7m.

5.Chapter 10.5.40.50.(2), By-law No. 569-2013

In the Residential Zone category, a platform without main walls, such as a deck, porch, balcony or similar structure, attached to or within 0.3 m of a building, must comply with the required minimum building setbacks for the zone. The minimum required side yard setback is 1.8m.

The proposed west side yard setback to the front porch is 0.61m.

6.Chapter 10.5.40.50.(2), By-law No. 569-2013

In the Residential Zone category, a platform without main walls, such as a deck, porch, balcony or similar structure, attached to or within 0.3 m of a building, must comply with the required minimum building setbacks for the zone. The minimum required side yard setback is 1.8m.

The proposed east side yard setback to the rear platform is 1.12m.

7.Chapter 10.20.30.10.(1)A), By-law No. 569-2013

The required minimum lot area is 550 square m.

The proposed lot area is 274.3 square m.

8.Chapter 10.20.30.20.(1)A), By-law No. 569-2013

The required minimum lot frontage is 15 m.

The proposed lot frontage is 7.63 m.

9.Chapter 900.3.10.(5)A), Exception RD 5, By-law No. 569-2013

Despite regulation 10.20.40.70 (3), the minimum side yard setback is 1.8 m.

The proposed east side yard setback is 0.92m.

10.Chapter 900.3.10.(5)A), Exception RD 5, By-law No. 569-2013

Despite regulation 10.20.40.70 (3), the minimum side yard setback is 1.8 m.

The proposed west side yard setback is 0.61m.

11.Chapter 10.20.40.50.(1)B), By-law No. 569-2013

The permitted maximum area of each platform at or above the second storey of a detached house is 4.0 square m.

The proposed area of each platform at or above the second storey is 8.38 square m.

The Committee of Adjustment considered the written submissions relating to the application made to the Committee before its decision and oral submissions relating to the application made at the hearing. In so doing, **IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:**

The Minor Variance Application is Refused

- The general intent and purpose of the Official Plan is not maintained.
- The general intent and purpose of the Zoning By-law is not maintained.
- The variance(s) is not considered desirable for the appropriate development of the land.
- In the opinion of the Committee, the variance(s) is not minor.

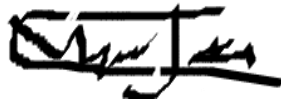
