SUMMARY

Composition of the Larry Grossman Forest Hill Memorial Arena Board

The board consists of 10 members and is composed of:

- The Councillor for Ward 8
- 8 public members, including
 - one member nominated by the Forest Hill Hockey Association, as long as they remain a primary tenant in the premises; and
 - one member nominated by the Forest Hill Skating Club, as long as they remain a primary tenant in the premises.
- 1 non-voting staff member from the Parks, Forestry and Recreation Division

There is one position under consideration

At its meeting on October 11 and 12, 2023, City Council increased the number of public members on the Larry Grossman Forest Hill Memorial Arena Board of Management to eight to now include one member nominated by the Forest Hill Skating Club, as long as they remain a primary tenant in the premises.

The Forest Hill Figure Skating Club has nominated Blair Naiberg as their member.

Term of office

The term of office for public members on the Larry Grossman Forest Hill Arena Board is four years. The member nominated by the Forest Hill Figure Skating Club will serve a term of office ending January 25, 2028, and until a successor is appointed.
