Re: Arbo Neighbourhood (formerly William Baker), 1350 Sheppard Avenue West Subdivision Application 21 119572 NNY 06 SB Public Meeting on January 24, 2024

Canada Lands Company CLC Limited ("Canada Lands") is very pleased to be seeking approval of our application for Draft Plan of Subdivision for Phase 1 of our Arbo (formerly "William Baker") Neighbourhood. This is an important step in the delivery of much-needed housing (both market and 20% affordable), along with key community benefits including two new public parks, the dedication of a natural heritage woodlot, and a significant financial contribution to the future Downsview Community Recreation Centre.

Application Status

The application preparation process started in early 2019 and included a rigorous and comprehensive consultation strategy undertaken by Canada Lands and its consultant team. This consultation process included a series of public open house sessions, pop-up consultations, meetings with various local stakeholder groups and online feedback.

Our team has worked diligently with our stakeholders and City staff to evolve the vision and details for the Neighbourhood since the formal application submission in early 2021, which included both a Zoning By-law Amendment and a Draft Plan of Subdivision application. Building on our zoning approval in Summer 2022, we now have a plan that is supported by the community and that contributes significantly to the urban fabric of the City of Toronto.

We have reviewed the Staff Report, dated January 10, 2024. A critical component of the report is the set of Conditions of Draft Plan Approval, on which we have been diligently working with City staff to finalize. While we are generally in agreement with the intent of the conditions, we have raised concerns with specific language, including timing, logistics, and implementation costs, however we had not had an opportunity to review the revised Conditions, included with the Staff Report until Monday, January 22,2024. We look forward to continuing to work with City staff to resolve these concerns.

Canada Lands is being pushed from all directions to enable housing opportunities as quickly as possible, a goal we all share.
