

**City of Toronto Act, 2006 Public Notice**

**RentSafeTO Update Report**

**Toronto City Council will be considering recommendations to adopt amendments to City of Toronto Municipal Code Chapter 354, Apartment Buildings and Chapter 441, Fees and Charges as part of an update report on the RentSafeTO: Apartment Building Standards program.**

It is proposed that the amendments be adopted at the City Council meeting to be held on April 17, 18 and 19, 2024 or at a subsequent meeting. If adopted by City Council, the amendments will:

Amend Toronto Municipal Code Chapter 354, Apartment Buildings to:

1. Remove 354-3.11. COVID-19 measures.
2. Amend 354-3.2B to add that all information required to be posted on the notification board shall be posted in a manner that ensures each piece of information is completely visible to tenants.
3. Add a provision to 354-4.1 B(5) to require the owner or operator to include in their logs of all pest treatment activities, the date of a follow-up inspection, if any.
4. Amend 354-5.1B so that the Executive Director is authorized to conduct targeted engagement visits in apartment buildings, and that the owner or operator shall pay any fees in accordance with Chapter 441, Fees and Charges.

Amend Chapter 441, Fees and Charges, Appendix C – Schedule 12, Municipal Licensing and Standards by amending the fees to read as set out in the table below:
