## RE: PH11.2 Our Plan Toronto: Official Plan Chapter One - Decision Report – Approval

Dear Chair Gord Perks and Members of Planning and Housing Committee,

While we support the updating of the Official Plan Chapter 1, we believe that the statement does not yet stress enough the crucial goal of increasing Toronto's liveability – - physical, economic, social and spiritual and the critical aim of developing and retaining complete communities.

Among other things, Toronto badly needs lively democratic participation: In its 2023 Vital Signs report<sup>1</sup> the Toronto Foundation documented a troubling reduction in civic engagement and volunteerism. In part, for this we fault the provincial government, which often overrules City decision-making (as in OPAs 405- Yonge-Eglinton, and 406- Downtown Secondary Plans), and tightens the time frame for municipal decision-making in development approvals, reducing public information and restricting occasions for engagement (for example by causing elimination of Preliminary (staff) Reports.

Given this erosion of our democratic involvement in the direction of the City, the Official Plan Chapter One needs to present the City as a strong defender of healthy democratic practices through full and vibrant civic consultation and engagement as this participation connects (binds) its residents into a community (network) that helps the city define and prioritize the evolving interrelationships of the physical, economic, and shared values that maintain social cohesion and a sense of belonging.

We therefore strongly object to the report's proposed preference for "virtual" consultation<sup>2</sup>. Virtual engagement helped us to survive COVID – but, neither sufficient, nor fulfilling, it ill suits normal times.

In addition, we suggest that the document commit to periodic assessment of planning's progress, according to key metrics.
