PROPOSAL

The application to amend the Zoning By-law proposes the development of one 21-storey residential tower (inclusive of the existing 5-storey parkade) on the western portion of the site. Several additions and alterations are also proposed across the entire site. Overall, the proposal would introduce 249 new dwelling units, 43 new hotel suites, and changes to the public realm surrounding 396 Queens Quay West.

FURTHER INFORMATION

If you wish to be notified of the decision of the City of Toronto on the proposed passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk Attention: Cathrine Regan, Administrator, Toronto and East York Community Council at the address, fax number or e-mail set out above.

Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal

the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submission at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

People writing or making presentations at the public meeting: The City of Toronto Act,

2006, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
