#### **PROPOSAL**

This application proposes to demolish 15 existing rental dwelling units located at 648 Yonge Street, 660 Yonge Street, and 664 Yonge Street in order to redevelop the lands with a 75-storey mixed-use building.

A Rental Housing Demolition and Conversion application (22 242933 STE 13 RH) under Section 111 of the City of Toronto Act, 2006 (Chapter 667 of the Municipal Code) has been submitted to permit the demolition. Under the City of Toronto Act, 2006, the demolition of a rental property with six or more dwelling units is prohibited without obtaining a permit from the City. Decisions by City Council on the rental housing demolition application are not subject to appeal to the Ontario Land Tribunal (OLT).


