NOTICE OF PUBLIC MEETING

To be held by the Toronto and East York Community Council (Under the Planning Act)

Request to Amend the Official Plan and Zoning By-law Application Number: 22 241665 STE 13 OZ

Location of Application: 646-664 Yonge Street and 2-4 Irwin Avenue

Applicant: KS 646 Yonge Street Inc.

PROPOSAL

The applicant has submitted an application to amend the Official Plan and Zoning By-law in order to construct a 75-storey mixed-use building at 646-664 Yonge Street and 2-4 Irwin Avenue. The proposal contains approximately 47,000 square metres of gross floor area, of which approximately 360 square metres is commercial space at grade. The existing buildings on the properties would be demolished, including 15 rental housing units which are to be replaced within the new building. The proposal incorporates the assets of two designated heritage buildings at 650 and 664 Yonge Street into the new building.

A related Rental Housing Demolition and Conversion application (22 242933 STE 13 RH) under Section 111 of the City of Toronto Act (Chapter 667 of the Municipal Code) to permit the demolition and replacement of 15 existing rental dwelling units on site has also been made and will be considered at the same time as the Official Plan Amendment and Zoning By-law amendment applications.



FURTHER INFORMATION

If you wish to be notified of the decision of the City of Toronto on the proposed passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk Attention: Cathrine Regan, Administrator, Toronto and East York Community Council at the address, fax number or e-mail set out above.

Official Plan and Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted or refused Zoning Bylaw Amendment is passed or refused, the person or public body is not entitled to appeal the decision.



If a person or public body does not make oral submission at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted or refused, and Zoning By-Law Amendment is passed or refused, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal

information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.

Many Committee, Board and Advisory Body meetings are broadcast live over the internet for the public to view. If you speak at the meeting you will appear in the video broadcast.
