FINANCIAL IMPACT

The total contract award identified in this report is \$685,852. including all applicable taxes and charges. The cost to the City is \$617,631 net of HST recoveries.

The engineering estimate for this project is \$667,858 net of all taxes and charges.

Funding is included in the 2025 Operational Budget for Transportation Services. Additional funding details follow in Table 1.
