Description:

For the supply and delivery of all labour, materials, equipment, and supervision required to complete Baycrest Park Revitalization Project for Parks and Recreation.

Recommended Supplier:

671860 Ontario Inc. o/a Somerville Construction

Contract Award Value:

\$ 8,660,000 net of all applicable taxes and charges.

\$ 9,785,800 including all applicable taxes and charges.

\$ 8,812,416 net of HST Recoveries

The contract is expected to start on the date of award and end by September 30, 2028. This includes a two (2) year warranty period.

FINANCIAL IMPACT

The total contract award identified in this report is \$ 8,660,000 net of all applicable taxes and charges, \$ 9,785,800 including all applicable taxes and charges. The cost to the City is \$ 8,812,416 net of HST recoveries.

The construction estimate for this project is \$ 8,092,447 excluding all applicable taxes and charges.

Funding for this project is included in the 2025 Capital Budget and 2026-2034 Capital Plan for Parks and Recreation as summarized in Table 1 below.
